#### **F1** Natela Abashwili failure to recognize her son.

-She forgets her child at the time of war and only considers salvaging her clothes and boots. Instead, the maid escapes with the child to save his life but later on Natela goes for the child because she wants to inherit the governor's estate.

-She loses both the child and the estate. (pg 24-25) (pg 90-98)

#### **FII** The Fat Prince's failure to recognize the leadership of the Governor (his brother).

√He becomes greedy and hungry for power. (pg19)

-The Fat Prince eliminates his brother to get his power. (pg20) .

√The Fat Prince is later also toppled and beheaded. (Pg58/59)

#### **FIII** The Governors' lack of concern for his subjects.

✓He oppresses his subjects by forcing the young men to go to war, ignoring the high taxation. He ignores complaints on corruption while he misuses government resources.

✓He finally loses power when he is overthrown and beheaded. His family disintegrates.

**FIV** Natela's hatred for the poor.

She undermines Grusha and Azdak during the court case. She feels that Grusha is too poor to keep the child. (pg85)(pg88) (pg94)

## **3 (20 Marks)**

### **The optional set texts**

#### **3. a) Introduction**

Expect a general or specific introduction.

The youth have always not hesitate to go abroad for studies. The desire for this is actually as a result of a number of factors such as availability of scholarships, bureaucracy at home, influence from other people and a wish to go out. This is evident in the short story leaving as discussed below. (Accept any other relevant introduction= 2 marks)

Content

M(i) Corrupt bureaucrats at the local level of admission to the universities, who deny students the opportunity to study the programs they are interested in. Aloo scores an 'A' and applies for a degree in medicine at a local university only to be admitted for a degree in Agriculture, a course he dislikes. ( pg35). Aloo blames everything on arbitrary officers at the ministry.

M(ii) Mr. Datto's return from America is also an inspiration that you can go abroad study and return. Aloo therefore starts to apply for university studies in America despite his mother's scepticism. He also observes "so many kids go and return and nothing happens to them" (pg36)

M(iii) There's also adventure associated with studying abroad. Aloo is excited when he receives a scholarship to study at the California Institute of Technology- America. He feels the 'whole universe lies out there waiting for him.

M(iv) Availability of a scholarship which can only be undertaken in the awarding country. In this case the scholarship given to Aloo can only be undertaken in California and had he been given one in his own country, it would be possible to study at home. Conclusion The youths are motivated by several factors that attract them to study in abroad in order to achieve their dreams. African countries should ensure the education system is transparent particularly at the level of choosing universities and courses.

## **b) Introduction**

If a character engages in doing evil things, there is usually a consequence to that. This is evident in Betrayal in the City through Mulili, Nicodemo, Tumbo and Boss.

E(i) Mulili engages in evil things by betraying Jere to Boss. Jere is then imprisoned yet Jere never betrays Mulili when he (Mulili) allows Mustafa to escape. Mulili is also involved in the murder of Nina and Doga, two innocent people who are only interested in fulfilling traditions in relation to their son's death that is, conducting a shaving ceremony for the late Adika.

-Mulili also arranges the killing of Kabito after they disagree during the meeting to arrange for the welcoming of the expected visitor.

-For all these Mulili pays the price when, at the end of the play he is shot dead by Juser.

E(ii) Nicodemo perpetrates evil when he accepts to be misused to incriminate an innocent man, Mosese. Nicodemo plants a one kilogramme of opium in Moseses' car and Moses is arrested and then imprisoned. Nicodemo pays the price when a decision is made that the prisoners, Mosese included, will act in front of the expected visitors and there is a likelihood that the prisoners will be pardoned after that. Nicodemo fears coming face to face with Moseses because he feels guilty of what he's done.

E(iii) Tumbo talks of having sold his scholarship to go to the university, signaling his corrupt character. He also pockets two-thirds of the 600 pounds set aside for the play writing competition and only promises to give Juser and Regina one-third of the money. He unilaterally declares Juser the winner of the play writing competition yet no other plays are submitted for the competition. Tumbo also plans for Regina to see Boss to plead for Mosese's release, yet he knows Boss's weakness as concerns to women. Tumbo further messes up by not watching the prior performance of the play before the final rehearsal that is being presented to Boss. This inefficiency merges when the play is stage and there is a coup d'état. Tumbo is told by Mosese "...it was largely through your inefficiency that we have achieved this".

E(iv) Boss's leadership is also riddled with evil through his over-reliance on the advice and reports of his semi-literate cousin. The cousin makes him part and parcel of the murder of Doga, Nina and Kabito. Never does he find out the truth behind certain allegations from Mulili that are mostly lies and baseless. He pays the price when Mulili betrays him and he (Boss) eventually requests Jere to shoot him.

### **c) Introduction**

Nani Flowers is portrayed as a character who cannot be put down under any circumstances. In a community which is patriarchal in nature, she opts to defend herself and other females in her household and society.

N(i) She is loving/adoring/caring. She goes out of her way to defend her great grandchild against Koro Apirana's prejudice. She defends Porourangi's decision to name her 'Kahu' despite it being a man's name. She hits the narrator for over working the girl and taking her to movies she also refuses to allow Koro Apirana to alienate the girl and encourages Kahu to pester him for attention. Despite her obvious disapproval of Koro Apirana's mannerisms, she truly loves him and fondly calls him 'Old Paka'

N(ii) She is assertive/independent-minded as a wife and grandmother. She tells Koro Apirana occasionally that she will divorce him to marry Waari if he continues to annoy her. She pulls his boat back to the beach as he sulks after quarreling with her. She insists on bringing back to the community Kahu's afterbirth and birth cord despite Koro Apirana's opposition. She demands that women should be allowed to participate in meetings and saving the ancient bull whale.

N(iii) She is also strong willed /courageous. She says she belongs to the Muriwai people whose fierceness is legendary. Indeed, Koro Apirana agrees with her and says her Muriwai blood is too strong thus it has led to the birth of a girl as a heir in the family. She defends the decision to name Porourangi's child, Kahu, and quarrels and challenges Koro Apirana on almost everything. It is said she is always stepping out of line.

N(iv) She is foresighted/visionary. She is able to notice the extraordinary abilities and qualities in Kahu. That's why she buries her afterbirth and birth cord in front of the tribe's meeting house. She encourages the girl to attend the men's meetings by threatening Koro Apirana whenever he sends Kahu away together with the narrator, she notices that Kahu is no ordinary girl while she is retrieving the carved stone from the floor of the ocean. She also notices that the girl is communing with the dolphins and she bids her time waiting for the right signs of what is to come.
